Because global markets don't always move in sync, losses in one region can be balanced by gains in another, helping to smooth overall portfolio returns and reduce risk.



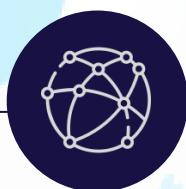

The investment approach blends value, growth, and ESG (Environmental, Social and Governance) strategies to pursue medium to long-term returns, capital appreciation and positive societal impact.

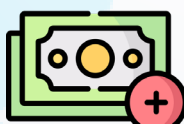


TACTICAL REBALANCING
