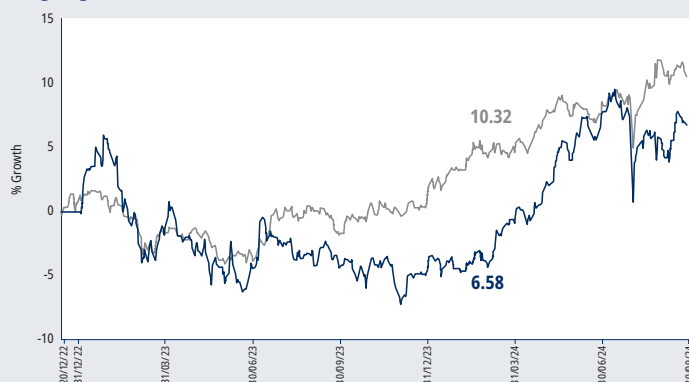

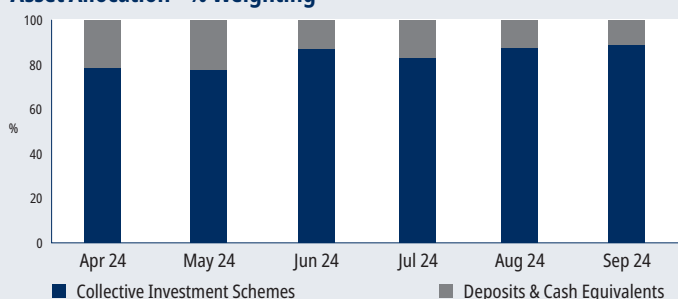

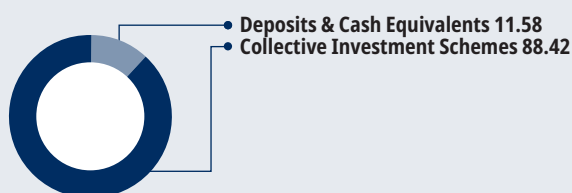
Asset Allocation - % Weighting
